**(3) MEASLES IMMUNIZATION POLICY:** Since the fall semester 1986, the Board of Curators has endorsed a mandatory two-dose measles immunization policy that states that no person born after 1956 shall attend a University of Missouri campus without documented proof of adequate immunizations. To reduce the potential for measles outbreaks, the MU campus has adopted the Centers for Disease Control (CDC) and Missouri Department of Health recommendation that all newly enrolled or readmitted college students provide documentation of two doses of measles vaccine to demonstrate adequate measles immunity. Those entering who do not comply with this policy may not be allowed to register the following semester. This policy excludes students matriculating only in off-campus or continuing education/extension courses. Upon presentation of supportive evidence, a waiver for religious or medical reasons may be granted by the Student Health Center.
